## ICD-11: Implementation Considerations

The International Classification of Diseases, now the 11th edition, is currently an active, international standard. Countries around the world have implemented and others have begun assessing ICD-11 to guide adoption and implementation.

The Webinar presented by Kathy Giannangelo, MA, RHIA, CCS, FAHIMA will provide a summary of recent ICD-11 implementation activities in various countries. Next, accomplishments of the National Committee for Vital and Health Statistics workgroup and their most recent recommendations will be covered. An overview of the stakeholder responses to the two Requests for Information are addressed. Concluding the presentation is the identification of stakeholder needs for the effective U.S. implementation of ICD-11.

Giannangelo is President of KGC, LLC and has extensive experience in the field of clinical terminologies, classification, and data standards. She serves as editor of AHIMA's Healthcare Code Sets, Clinical Terminologies, and Classifications textbook. In addition, she has authored numerous articles, created online continuing education courses, and has presented worldwide.
